Once InterWrap has received a purchase order from the distributor and a signed authorization from the Dual Logo customer, the order can no longer be cancelled. Manufacturing's goal is to produce the order as requested but reserves the 10% ± variance.
Customer agrees to accept and pay for complete orders including any variance. InterWrap will not retain or store any leftover inventory for the customer.
Completion of manufacture will be approximately 4 weeks plus transit time.

Note: All text must be converted to outlines/curves and in a scalable vector file format. Printing plates cannot be produced from jpgs or bmps such as those copied from websites.

When you receive the proof via email, **CHECK IT VERY CAREFULLY**. You are responsible for final proofing. Sign and return asap. The order will be processed once we have the following:

- 1. A returned proof, signed and approved
- 2. A Distributor purchase order including plate fee for first time order
